Comments from Highways

This shows an average speed of 29.8mph and an 85%ile speed of 35mph, which I believe may be high enough to warrant some enforcement from the Police.

This location is to be added to the agenda of the next CRASH, multi-agency group meeting, for discussion and possibly some Police enforcement; also we will assess the existing signage to ensure if meets the current standards in terms of size and positioning, and look at any changes we can make to improve driver awareness of the 30mph speed restriction.

In addition, the Community Police Officer is arranging for the speed camera van to be deployed and to be supplemented by him using a radar gun, from his patrol vehicle.
